The appointees shall be on probation for a period of two years and shall be allowed to join only on production of the following certificate/documents in original:-

- Educational/Technical Qualification like Degree/Diploma issued by the recognized Institution/University valid for employment in J&K
- Date of Birth certificate (Secondary School Examination 11. Certificate/Matriculate Certificate).
- Permanent Resident Certificate. iii.
- Health Certificate issued by an Officer of the State Health iv. Department not below the rank of Chief Medical Officer.
- Character and Antecedents certificate issued by the Competent V. Authority/State CID Department.
- Certificate from concerned Competent Authority to the effect vi. that the candidate has not availed any loan under any State Self Employment Scheme.
- Any other relevant certificate as required under rules. vii.

Further, the above appointment is provisional and subject to the following conditions:-

- a. The Chief Engineer, RTIC and I&FC Department, Jammu shall personally verify the genuineness of institution and qualification Certificate/ Permanent Resident Certificate and other certificates under rules.
- b. The appointees shall furnish an undertaking in the shape of an affidavit that in case any adverse report about their character and antecedents is received from the IG, CID/C.I. Department, J&K to whom a reference shall be made by the authority to whom they shall submit their joining report or any other adverse report about their qualification is received, the candidate(s) shall have no right to claim their appointment as Draftsman (Civil) and their appointment as such shall be deemed to be void-ab-initio and cancelled as such.
- c. Salary of the appointees shall not be drawn and disbursed to them unless a satisfactory character and antecedent report is received from the IG, CID and verification of genuineness of the qualification and all other certificates is received from the concerned authorities.

Consequent upon their appointment, S.No 1 and S. No 2 shall report within 21 days to the Chief Engineer RTIC and I&FC Department, Jammu respectively.

The inter-se seniority of the appointee Draftsman(Civil) shall be in order of merit as determined by the J&K Services Selection Board and shall be notified separately.

This order is issued subject to outcome of writ petition(s), if any, pending in any Court of competent jurisdiction.
