The appointee(s) shall be allowed to join only after production of the following certificates/documents (in original) to be verified separately:-

- Academic/Technical qualification Certificates.
- Matriculation/Date of Birth certificate.
- Domicile certificate issued by the Competent Authority.
- Health Certificate from the concerned District Chief Medical Officer.
- Certificate from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under any Self Employment Scheme has been availed by the candidate.
- Relevant category certificate issued by the Competent Authority, if any applicable.

The appointment of the above candidates shall further be subject to the following conditions:-

1. Each appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his/her Qualification/ Date of Birth/ Reserved Category Certificates from the concerned issuing authorities is found fake/forged, his/her appointment as (MTS) in the Jal Shakti Department shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her.
2. That if the candidate(s) has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the Domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before the joining the Government Services. He/ She shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stacks, if any in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery.
3. Each appointee shall furnish an Undertaking in the shape of Affidavit as per Annexure-A to this order.
4. The salary of the appointees shall not be drawn and disbursed to him/her unless satisfactory report in respect of genuineness of his/her qualification/Relevant Category Certificate/ Date of birth and other pre-requisite certificate(s) is received from the concerned issuing authority/Agency.
5. The inter-se-seniority of the appointees shall be determined in accordance with the merit secured by him/her in the selection list prepared by the J&K Services Selection Board and in terms of J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
6. The appointment of the candidates shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
7. The candidate(s) appointed under RBA category shall be posted in such areas at least for 7 years.
8. The appointee(s) shall be on probation for a period of two (02) years.
9. The appointments of the above candidates shall be subject to outcome of writ petition(s), if any, pending before any competent Court of Law.
