In continuation to Government order No. 41-JK (JSD) of 2024 dated 20.02.2024 and Government order No. 61-JK (JSD) of 2024 dated 07.03.2024, as recommended by the J&K Services Selection Board conveyed vide above reference, sanction is hereby accorded to the temporary appointment of Mr. Murtaza Hussain S/o Gh. Nabi Bhat R/o H.No. 804, Mir Mohalla Aripal Pulwama, 192123 as Draftsman (Civil) Divisional Cadre, Kashmir, in the Pay Level-4 (25500-81100) under RBA category in Jal Shakti Department notionally w.e.f 20.02.2024 and monetarily with immediate effect:

Consequent upon his appointment, the candidate shall report in the office of the Chief Engineer, I&FC Kashmir within a period of twenty one (21) days from the date of issuance of this order. In case the candidate fails to join within the stipulated period, his appointment shall be deemed to have been cancelled ab-initio without any notice.

The appointee shall be allowed to join only after production of the following certificates/documents (in original) to be verified separately:-

- i. Educational/Technical qualification (Diploma Certificates) issued by the recognized Institute / University.
- ii. Matriculation/Date of Birth certificate.
- iii. Domicile certificate issued by the Competent Authority.
- iv. Health Certificate from the concerned District Chief Medical Officer.
- v. Certificate from the District Industries Centre (DIC) and District Employment and Counseling center to the effect that no loan under any self employment scheme has been availed by the candidate.
- vi. Valid relevant category certificate issued by the Competent Authority.

The appointment of the above candidate shall further be subject to the following conditions:-

1. Appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his Qualification/ Date of Birth/ Reserved Category Certificate from the concerned issuing authorities is found fake/forged, his appointment as Draftsman (Civil) in the Jal Shakti Department shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.

2. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the Domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before the joining the Government Services. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stacks, if any in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery.
3. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of genuineness of his qualification/Relevant Category Certificate/ Date of birth and other pre-requisite certificate(s) is received from the concerned issuing authority.
4. The inter-se-seniority of the appointee shall be determined in accordance with the merit secured by him in the selection list prepared by the J&K Services Selection Board and in terms of J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
5. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
6. The candidate appointed under RBA category shall be posted in such area for at least 7 years.
7. The appointee shall be on probation for a period of two (02) years.
8. The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, pending before any competent Court of Law.
