Subject: Year-wise Tentative Seniority lists of Superintending Engineers Civil (Hydraulic) of PHE, I&FC Department, from 01.01.2013 to 01.01.2017.

Whereas, the final seniority list of Superintending Engineers, Civil (Hydraulic) of PHE, I&FC Department, as it stood on 01.01.2012, was notified, vide Government Order No. 148-PW (Hyd) of 2015, dated 09.06.2015; and

Whereas, some Superintending Engineers have retired on superannuation in the intervening period and their names are required to be deleted from the seniority list; and

Whereas, Sh. K.K. Gupta, I/C Chief Engineer, figuring at S.No. 8 in the final seniority list of Superintending Engineer (Hydraulic) as it stood on 01.01.2012 issued vide Government Order No. 148-PW (Hyd) of 2015, dated 09.06.2015, was retired from the service under Article 226(2) of J&K Civil Services Regulations vide General Administration Department's Government Order No. 888-GAD of 2015, dated 30.06.2015, and his name is required to be deleted from the seniority list; and

Whereas, the seniority of a few I/C Superintending Engineers, whose cases of regularization/promotion as Superintending Engineers have been deferred by DPC/PSC on the directions of the Hon'ble Court, shall be fixed later at suitable places in the seniority list, as and when they are cleared for regularization/ promotion by DPC/PSC, after the final outcome of the writ petition(s) pending in the Hon'ble Court(s); and

Whereas, the year-wise seniority lists of the Superintending Engineers, from 01.01.2013 to 01.01.2017 are required to be issued to effect further promotions/regularizations of Superintending Engineers as Chief Engineers.

Now, therefore, the Tentative year-wise seniority lists of Superintending Engineers Civil (Hydraulic) from 01.01.2013 to 01.01.2017, forming annexure to this circular, are hereby issued. Members of the service are, accordingly, directed to file their objections, if any, in the Administrative

Department (HRM Branch, Room No. 28, 3rd floor, main Building, Civil Secretariat, Jammu) through their respective Heads of Department within a period of 21 days from the date of uploading of the aforementioned year-wise Tentative Seniority Lists on the official website i.e. www.jkpheirrigation.nic.in or the date of publication of an abridged notice in the leading newspapers stating that the aforesaid Tentative Seniority lists of Superintending Engineers Civil (Hydraulic) have been uploaded on the Departmental website, whichever is later, with documentary proof in support of their claims after which no objection(s) shall be entertained and the aforesaid Tentative Seniority Lists shall be issued.

The Dates of Birth of the officers as reflected in the above Tentative Seniority Lists shall be subject to authentication and verification from the Service Books/Date of Birth Certificates of the concerned employees, as envisaged under rules.
