Whereas, on the recommendations of Departmental Promotional Committee/J&K Public Service Commission, vide Government Order No.74-JK (JSD) of 2021 dated 19.03.2021, 137 Assistant Executive Engineers were regularized/promoted as Executive Engineers; and

Whereas, the DPC/PSC withheld the recommendations in favour some Assistant Executive Engineers for want of deficient documents and the recommendations for regularization/promotion as Executive Engineers will be released as and when the deficient documents are made available, with the approval of the Chairman DPC; and

Whereas, among others, the promotion/regularization of the following Assistant Executive Engineers as Executive Engineer was also cleared by the DPC/PSC, subject to deficient documents shown against each:-


