Whereas, on the recommendation of the General Administration Department/ACB, Shri Mohammad Muzaffar Wani, the then Junior Engineer, PHE Division, Srinagar (now JE PHE Division Chadoora) was placed under suspension vide Government Order No.179-JK(JSD) of 2021 dated 06.09.2021 and attached in the office of Chief Engineer, I&FC, Kashmir; and

Whereas, the case was examined in the department and vide this department's letter dated 27.10.2021, Memorandum, Article of Charges, Statement of Imputation and Gist of evidence was served to the accused officer through Chief Engineer, I&FC Kashmir; and

Whereas, in response, Shri Mohammad Muzaffar Wani the then Junior Engineer, PHE Division, Srinagar has submitted reply on 15.11.2021, in defence on the charge sheet served against him; and

Whereas, the case has been examined in the department and the Competent Authority has decided to appointed an Inquiry officer to enquiry into the charges framed viz- a- viz reply furnished by the accused officer.
