Whereas, a tentative seniority list of Superintending Engineers (Civil) Jal Shakti Department as it stood on 01.01.2022 was issued/notified for inviting the necessary objections, if any, for the members of the service, within a period of 15 days, vide Circular No. 06- JK(JSD) of 2022 dated 29.11.2022 from the date of issuance of the circular; and

Whereas, the department has received 03 No. of objections/ representations, as indicated below:-

S.No	Name of the Officer	objections/ representations	Disposal of objections
1	Shri Iftikhar Ahmad Wani, I/c Chief Engineer	He has represented for issuance of regularization order as Superintending Engineer in his favour	The officer does not figure in the tentative seniority list of Superintending Engineers. The officer faced a RDA and was placed under suspension in Handwara case and his period of suspension is yet to be decided. The DPC/PSC has recommended that after such decision, the matter will be considered for regularization. Therefore, the representation does not merit consideration at this stage.
2.	Shri Fida Hussain Wazir retired, I/c Superintending Engineer	The officer has claimed for promotion as Superintending Engineer as per reservation rules	Since, the matter is pending before the Hon'ble Supreme Court of India, as per General Administration Department O.M. No. GAD/MTG/ RB- IV/04/2016 dated 21.06.2016, the representation of the retired officer does not merit consideration at this stage.
3.	Shri Imtiyaz Ahmad Qazi, retired Executive Engineer	The officer has requested for releasing of grade of SE in his favour.	The officer was not placed as I/c Superintending Engineer in absence of vacancy at that point of time. Hence, rejected.

Whereas, the seniority of such officers whose regularization as Superintending Engineers has been deferred by the DPC/PSC for want of vigilance clearance, pending departmental enquiry or any other reasons, shall be fixed at appropriate places, after their regularization as Superintending Engineers are cleared by the DPC/PSC.

Now, therefore, final seniority list of (retired/in-service) Superintending Engineers (Civil), Jal Shakti Department as on 01.01.2022, is hereby issued **Annexure** to this Government Order for circulation among all the members of the service.

The seniority shall be without prejudice to the final outcome of writ petition (s), if any, pending before any competent Court of Law.

The date(s) of birth reflected in the final seniority list shall not be taken as authentic and shall be subject to the further verification from the Service Book/Matriculation certificate of the concerned Officer(s).




