The appointees shall report to the Deputy Secretary to the Government, Jal Shakti Department, Civil Secretariat, Srinagar within a period of twenty one (21) days from the date of issuance of this Government Order. In case he fail to join within the stipulated time, he shall forego his right of appointment and the appointment shall be deemed to have been cancelled ab-initio without any Notice.

The appointees shall be allowed to join after production of the following certificates/ documents (in original) to be verified subsequently;

- i. Educational/Technical Qualification (Degree Certificate) issued by the recognized Institute/University valid for employment.
- ii. Matriculation/DoB Certificate.
- iii. Domicile Certificate issued by the Competent Authority.
- iv. Health Certificate from the concerned District Chief Medical Officer.
- v. Certificate from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under any self employment scheme has been availed by the candidate.
- vi. Valid relevant category certificate issued by the Competent Authority.

Besides, the appointment of the above candidate shall further be subject to the following conditions;

- i. The appointee shall furnish an undertaking in the shape of affidavit as per the annexure "A" to this Government Order.
- ii. The salary of the appointee shall not be drawn and disburse to him unless and until satisfactory report in respect of the genuineness of his qualification/degree certificate/DoB/category certificate is received from the concerned issuing authorities.
- iii. The appointment of the candidate shall be governed in terms of Jammu & Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O. 192 of 2020 dated 17.06.2020.
- iv. The inter-se-seniority of the appointee shall be determined as per J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- v. The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, pending before any Competent Court of Law, which is not immediately in the knowledge of Department.
