Whereas, vide Government Order No.242-JK(JSD) of 2021 dated 20.12.2021, Sh. Vijay Kumar, the then I/C Superintending Engineer was appointed as Inquiry Officer to conduct de-novo enquiry into the allegations leveled against the Sh. Rohit Gupta, the then I/C Assistant Executive Engineer, Irrigation & Flood Control, Division Akhnoor. (now I/C Executive Engineer), Economic Reconstruction Agency, J&K; and

Whereas, Sh. Vijay Kumar, the then I/C Superintending Engineer, had not submitted the enquiry report and retired on superannuation on 28.02.2022, without submitting the enquiry report; and

Whereas, the case was again examined in the department and the Competent Authority has decided to appoint afresh Inquiry Officer to complete the enquiry in the matter; and

Now, therefore, Shri Ajay Kumar Gupta, I/C Superintending Engineer, RTIC Jammu is hereby appointed as Inquiry Officer to conduct de-novo enquiry on the allegations leveled in the complaint received from Zonal Headquarter Crime Branch Jammu against Shri Rohit Gupta, the then I/C AEE, Irrigation & Flood Control Division (now I/C Executive Engineer, ERA, J&K),

The Inquiry Officer shall submit his report/findings alongwith specific recommendations within 10 days positively from the date of issuance of the Government Order.
