Consequent upon his appointment, the appointee shall report in the office of the Chief Engineer, Irrigation and Flood Control, Kashmir within a period of twenty one (21) days from the date of issuance of this order. In case the candidate fails to join within the aforementioned stipulated period, his appointment shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join after production of the following certificates/documents (in original) to be verified separately:-

- I. Academic/Category Certificates.
- II. Matriculation/Date of Birth certificate.
- III. Domicile certificate issued by the Competent Authority.
- IV. Health Certificate from the concerned District Chief Medical Officer.
- V. If the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the Domicile District, he shall relinquish the proprietorship of unit/enterprise and also stacks, if any, in such self employment unit/enterprise before the joining the Government Services. He shall be required to liquidate the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stacks, if any in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- VI. Relevant category certificate issued by the Competent Authority, if any applicable.

The appointment of the above candidate shall further be subject to the following conditions:-

- a. The clearance received from the Criminal Investigation Department, J&K is provisional and it shall be mandatory for the appointee to fill in the Verification Rolls (V-Rolls) as available through the online mode under the Electronic Employment Verification System (EVS). Any false information provided by the appointee or an adverse finding subsequent to the V-Roll submitted electronically shall result in cancellation of appointment without any further notice.
- b. The appointee shall furnish an Undertaking in the shape of Affidavit as per **Annexure-A** to this order;
- c. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of genuineness of qualification/Date of birth/relevant category and Final Character & Antecedents Report is received from the concerned Authorities/Agency.
- d. The inter-se-seniority of the appointee shall be determined in accordance with the merit in the selection list prepared by the J&K Services Selection Board and J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- e. The appointee shall be on probation for a period of two (02) years as per Rule 20 of J&K Civil Services (CCA) Rules, 1956.
- f. The appointment of the above appointee shall be cancelled ab-initio, if it is found that he possess higher qualification than the prescribed one at any stage and he shall also be liable for criminal prosecution under law.
- g. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- h. The appointment of the above candidate shall be subject to orders in any legal proceedings in a Court/Tribunal.


