The appointees shall report to the Additional Secretary to the Government, Jal Shakti Department, Civil Secretariat, Jammu/ Srinagar within a period of twenty one (21) days from the date of issuance of this Government Order. In case any candidate fails to join within the stipulated time period, their appointment shall be deemed to have been cancelled ab-initio without any Notice.

The appointees shall be allowed to join after production of the following certificates/documents (in original) to be verified separately:-

- i. Educational/Technical Qualification (Degree Certificate) issued by the recognized Institute/University valid for employment.
- ii. Matriculation/DoB Certificate.
- iii. Domicile Certificate issued by the Competent Authority.
- iv. Health Certificate from the concerned District Chief Medical Officer.
- v. Certificate from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under any self-employment scheme has been availed by the candidate.
- vi. Valid relevant category certificate issued by the Competent Authority, if any applicable.

Besides, the appointment of the above candidates shall further be subject to the following conditions:-

- a. Each appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his/her Qualification/Date of Birth/Reserved Category Certificates from the concerned issuing authorities is found fake/forged, his/her appointment as Assistant Engineer in the Jal Shakti Department shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her.
- b. That if the candidate(s) has taken loan for self-employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the Domicile District, he/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO Concerned from his/her salary. DDO Concerned

- shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- c. The salary of the appointees shall not be drawn and disbursed to him/her unless satisfactory report in respect of genuineness of his/her qualification/Degree Certificate/Relevant category Certificate/Date of birth and other re-requisite certificate(s) is received from the concerned issuing authority.
 - d. The inter-se-seniority of the appointees shall be determined in accordance with the merit secured by him/her in the selection list prepared by the J&K Public Service Commission in terms of J&K Civil Services (Classification, Control and Appeal) Rules, 1956 while that vis a vis promotees shall be, in addition to the Rules, be also in accordance with the directions of the Hon'ble Court/ Tribunal.
 - e. The appointment of the candidates shall be governed by the "New pension Scheme" in terms of SRO-400 of 2009 dated 24.12.2009.
 - f. The candidates(s) appointed under RBA and ALC/IB category shall be posted in such areas at least for 7 years.
 - g. The appointee(s) shall be on probation for a period of two (02) years.
 - h. The appointments of the above candidates shall be subject to outcome of writ petition(s), if any, pending before any competent Court of Law.


