Subject: -Medical Reimbursement Claim of Er. Naresh Kumar I/C Chief Engineer I&FC Srinagar

Ex-post facto sanction is accorded to the reimbursement of medical expenses incurred by Er. Naresh Kumar I/C Chief Engineer Jal Shakti (I&FC) Department, Srinagar on treatment of his wife namely Smt. Shashi Prabha at Fortis Memorial Research Institute Gurugram, Haryana, in relaxation of Rule 6 (1) and 6-A of J&K Civil Services (Medical Attendance cum Allowance) Rules, 1990, subject to the fulfilment of following conditions at the time of disbursement of claim to the beneficiary:-

- 1- Reimbursement of charges shall be restricted to items/ procedures admissible under rules and cost thereof is restricted to the extent of rates as applicable to such items/procedures at AIIMS New Delhi. Reimbursement of the claim is further subjected to expenditure incurred beyond the package cost admissible under SEHAT Scheme for such treatment. The DDO shall confirm the package available for such treatment under the AB-PMJAY SEHAT Scheme from SHA in this regard.
- 2- All relevant medical bills/vouchers are verified from the concerned Medical Authority of the hospital where from treatment has been taken.
- 3- Essentially certificate on Form-2 issued by hospital authorities is obtained and kept on records.
- 4- Follow-up (if any), is regulated under rules.

This issues with the concurrence of Finance Department vide U.O No. FD-Code/135/2021-03-Part(2)-2053 dated 08/04/2024 and General Administration Department vide U.O No. GAD-CORD/51/2024 dated 27/05/2024.


