Whereas, District Development Commissioner, Doda vide letter No. DDC/Adm/PHE/2021-22/15325-28 dated 12.03.2022 intimated that the matter regarding Non-functional Water Supply Scheme Mandrala-Koti in Doda and swindling of funds of the scheme was raised in the "Mulaquat" of Hon'ble Lieutenant Governor U.T. of J&K and the applicant has logged afresh grievance dated 08.03.2022 with regard to latest status and measures taken to provide drinking water and action taken against the corrupt officials. District Development Commissioner. Doda has accordingly requested to accept the findings of the report and initiate necessary action against the delinquent officers/officials; and

Whereas. Chief Engineer PHE, Jammu vide letter No. PHEJ/DB/17769-70 dated 01.02.2022 intimated that a complaint regarding alleged swindling of funds allotted for execution for various components of the non-functional Water Supply Scheme Mandrala Koti in Doda had been made by the local inhabitants. DDC, Doda's office had conducted an enquiry into the matter and forwarded the report thereafter to Jal Shakti Department for further course of action; and



Whereas. Chief Engineer has also intimated that the Enquiry committee had already been constituted by this office under endorsement PHEJ/GE/1509-515 dated 23.09.2021, to look into the complaint of alleged swindling of funds allotted to the above said scheme and it being rendered nonfunctional. The Committee headed by the Superintending Engineer, Hydraulic Circle, Doda, was asked to conduct a thorough enquiry into the matter and submit a detailed report thereof regarding irregularities committed, if any in execution of the said water supply scheme; and

Whereas. Chief Engineer forwarded the Report of the Enquiry Committee, related to the case, the report of the enquiry committee was examined in the Department; and

Whereas, vide this department's letter dated 29.03.2022, Anti Corruption Bureau, J&K, Jammu was requested to investigate the matter and Chief Engineer, PHE Jammu was also requested to furnish the details/particulars of the officers/officials involved/posted during the period in question; and

Whereas, in response, Chief Engineer, PHE, Jammu vide letter No. PHEJ/GE/277 dated 07.04.2022 forwarded the details/particulars of the officers/officials who remained associated with the execution of the scheme during their period of stay in the Division, the details of officers/officials are as under:-
