The assigning of temporary charge to the above named officers shall be subject to the following conditions: -

- i. The arrangement is purely temporary to meet the administrative exigency without confirming any preferential right upon the officers to claim promotion on substantive basis till the posts are filled under rules by following due procedure.
- ii. The arrangement shall be subject to superior claim of any left-out officers if found genuine, or/ and outcome of writ petition(s) if any, pending in any competent Court (s) of Law which is not in the immediate knowledge of the department.
- iii. In case assigning of temporary charge is seized by any event, the incumbent (s) shall not have any preferential right to claim any benefit of instant assigning of charge of higher posts and will be reverted back without any notice.
- iv. That it shall not create any right, interest or equity in favour of the officer(s) as and when considered for promotion on substantive basis against the sanctioned posts.
- v. That in case, department receives any adverse remarks/ note in respect of any officer (s), in the shape of Vigilance Status/ APRs/ Integrity/ Work & Conduct Certificate, he/ she shall be reverted to his original position without any notice.
- vi. Their inter se- seniority shall be determined separately as per rules.

The above named officers shall continue to work at their present place of postings till further orders.


