- The assignment of charge will be an interim one, purely temporary in nature without conferring any preferential right on any of these officers to claim promotion which shall be made strictly in accordance with rules and only after the vacancies accrue within the authorized cadre strength.
 - The placement/assignment is subject to superior claim of any left-out officer, if found genuine or upon outcome of legal proceedings.
 - In case the requirement of the borrowing organizations ceases, or the officers deputed by the Jal Shakti Department are repatriated, the junior most officers shall be reverted from the higher posts and shall not have any claim of benefit of assignment of temporary charge of the higher post.


