Subject: Authentication of Date of Birth of Sh. Vishwa Nath (Driver).

Whereas, the Chief Engineer Rawi Tawi Irrigation Complex, Jammu vide his letter No. RTIC/5/2716 - 2717 Dated 29.11.2022 recommended the case of Sh. Vishwa Nath for authentication of his Date of Birth, for Administrative Approval, after AG office has pointed out that there was the mutilation in DOB of the official, attested by Executive Engineer without approval of competent authority; and

Whereas, the case was examined in the department and the Chief Engineer Rawi Tawi Irrigation Complex Jammu vide letter No. JSD-NGJ0GEN/72/2022 dated-21.12.2022 was requested to get the 9th class certificate issued by Head Master, Govt. High School Marh authenticated/ countersigned by concerned Chief Education Officer; and

Whereas, the Chief Engineer, Ravi Tawi Irrigation Complex Jammu vide letter No. RTIC/J/4118-4119 dated 11.02.2023 has intimated that the date of birth of Mr. Vishwa Nath, Driver of his office has been verified from Jammu and Kashmir State Board of School Education as well as Chief Education Officer, Jammu which reveals that the correct date of birth of Shri Vishwa Nath (Driver) is 16.10.1964 (Sixteen October Nineteen Hundred Sixty Four; and

Whereas; the case was again examined in the department in consultation with the Director, Finance, and was accordingly, decided to settle the case in terms of Rule 287 of GFR 2017.

Now, therefore, sanction is hereby accorded to authenticate the date of birth of Mr. Vishwa Nath (Driver) as 16.10.1964 (Sixteen October Nineteen Hundred Sixty Four) in terms of Rule 287 of GFR 2017 and Article 35-AA of JKCSR Volume-I.
