In terms of Rule 6 (1) and 6-A of J&K Civil Services (Medical Attendance cum Allowance) Rules, 1990, Post facto sanction is accorded to the reimbursement of medical expenses beyond **Rs.5.00 lacs** incurred by Sh.Bashir Ahmad ALM of PHE Division Baramulla for treatment of his wife namely Rafiaqa Begum at Yashoda Hospital Secunderabad during the period of hospitalization subject to the following conditions:-

- I. Reimbursement of charges shall be restricted to items/procedures admissible under rules for the period of hospitalization and cost thereof shall be restricted to the extent of rates as applicable to such items/procedures at AIIMS New Delhi.
- II. All relevant medical bills/vouchers shall be got verified from relevant Medical Authority of the hospital where from treatment has been taken.
- III. Essentiality certificate on Form 2 issued by the hospital authorities is obtained and kept on records.
- IV. Certificate from the Competent Medical Authority (Director Health Services/Principal GMC/other) is obtained to establish the genuineness of the treatment availed in the said hospital.
- V. Follow up (if any), is regulated under rules.


