- II. Matriculation/Date of Birth certificate.
- III. Domicile certificate issued by the Competent Authority.
- IV. Health Certificate from the concerned District Chief Medical Officer.
- V. Certificate from the District Industries Centre (DIC) and District Employment and Counseling centre to the effect that no loan under any self employment scheme has been availed by the candidate.

The appointment of the above candidates shall further be subject to the following conditions:-

In case during the course of verification of the requisite documents, turns out to be fake/fictitious, the appointment shall be cancelled ab-initio and appropriate criminal proceedings against such candidate(s) shall be initiated accordingly.

3. The appointment of the candidates shall be governed in terms of the Jammu and Kashmir Probationer (Condition of Service, pay and allowances) and Fixation of Tenure Rules, 2020

notified vide S.O 192 of 2020 dated 17.06.2020.

4. The inter-se-seniority of the appointee shall be determined in accordance with the merit secured by the appointee in the selection list prepared by the Services Selection Board.

5. The candidate(s) appointed under RBA and ALC/IB category shall be posted in such areas at

least for 7 years.

6. The appointment of the above candidates shall be subject to outcome of writ petition(s), if any, pending before a competent Court of Law.
