Ex-post facto sanction is accorded to the reimbursement of medical expenses incurred by Mr Qazi Qudrat Ali I/c Executive Engineer Flood Control Division Anantnag on his own treatment in relaxation to Rule 6 (1) & Rule 6 (A) of J&K Civil Services (Medical Attendance cum Allowance) Rules, 1990, for taking treatment outside the state subject to the following conditions which shall be fulfilled by the concerned Drawing and Disbursing Officer at the time of disbursement of claim to the beneficiary:-

- i. Reimbursement of charges shall be restricted to items/procedures admissible under rules for the period of hospitalization and cost thereof is restricted to the extent of rates as applicable to such items/ procedures at AIIMS New Delhi.
- ii. All relevant medical bills/vouchers shall be got verified from relevant Medical Authority of the hospital where from treatment has been taken.
- iii. Essentially certificate on Form 2 issued by the hospital authorities is obtained and kept on records.
- iv. Certificate from the Competent Medical Authority (Director Health Services/Principal GMC/other) is obtained to establish the genuineness of the treatment availed in the said hospital.
