Consequent upon his appointment, the candidate shall report in the office of Chief Engineer, Jal Shakti (PHE), Kashmir within a period of twenty one (21) days from the date of issuance of this order. In case the candidate fails to join within the stipulated period, his appointment shall be deemed to have been cancelled ab-initio without any further notice:

The appointee shall be allowed to join after production of the following certificates/documents (in original) to be verified separately:-

- I. Educational/Technical qualification (Degree/Diploma Certificates) issued by the recognized Institute / University.
- II. Matriculation/Date of Birth certificate.
- III. Domicile certificate issued by the Competent Authority.
- IV. Health Certificate from the concerned District Chief Medical Officer.
- V. Relevant category certificate issued by the Competent Authority, if any applicable.

The appointment of the above candidate shall further be subject to the following conditions:-

1. The appointee shall furnish an undertaking in the shape of an affidavit to the effect that he has no criminal record and is not facing any criminal proceedings in any Hon'ble Court of Law.
2. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the Domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before the joining the Government Services. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery.

3. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of genuineness of his qualification/Relevant Category Certificate/ Date of birth and other pre-requisite certificate(s) is received from the concerned issuing authority.
4. The inter-se-seniority of the appointee shall be determined in accordance with the merit secured by him in the selection list prepared by the J&K Services Selection Board and in terms of J&K Civil Services (Classification, Control and Appeal) Rules, 1956
5. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
6. The appointee shall be on probation for a period of two (02) years.
7. The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, pending before a competent Court of Law.
