Whereas, the Chief Engineer I&FC Kashmir vide his letter No. 14311-13 dated 05.02.2024 recommended the case of Mr. Ghulam Nabi Wani, Ex-Helper for authentication of his Date of Birth, as the Accountant General office has pointed out that there was the mutilation in DOB of the said retired official; and

Whereas, the case was examined in the department and the Chief Engineer, I&FC Kashmir vide letter No. JSD-NGK/48/2024/7431595 dated 04.04.2024 was requested to furnish the copy of authenticated first page of Service Book of the said retired official and copy of D.O.B proof i.e Medical Certificate dated 22.06.1995 issued by the Chief Medical Officer Anantnag on the basis of which his service book was made from the relevant point of time; and

Whereas, the Chief Engineer, I&FC Kashmir vide his letter No. 3404 dated 29.05.2024 has forwarded the copy of Medical Certificate dated 22.06.1995 issued by the Chief Medical Officer Anantnag; and

Whereas, the case was again examined in the department and in consultation with the Director Finance, and accordingly it has been decided to settle the Date of Birth of the ex-official, in terms of Rule 35-AA of J&K Civil Service Regulations.

Now, therefore, in terms of Rule 287 of GFR 2017 and Article 35-AA of JKCSR Volume-I, the date of birth of Mr. Ghulam Nabi Wani, Ex-Helper is deemed to have been authenticated as 22.12.1961 (Twenty-Second December Nineteen Hundred Sixty-One).
