

The 6th International Dam Safety Conference-2022 is being held during 10-12 October 2022 at Birla Auditorium at Jaipur, Rajasthan, is a joint initiative of Central Water Commission, Government of India; Indian Committee on Large Dams (INCOLD), CBIP, and the ongoing World Bank assisted Dam Rehabilitation and Improvement Project (DRIP) Phase - II and III.
