

The appointee(s) shall be allowed to join after production of the following certificates/documents (in original) to be verified separately:-

- I. Academic/Technical qualification Certificates.
- II. Matriculation/Date of Birth certificate.
- III. Domicile certificate issued by the Competent Authority.
- IV. Health Certificate from the concerned District Chief Medical Officer.
- V. Certificate from the District Industries Centre (DIC) and District Employment and Counseling centre to the effect that no loan under any self employment scheme has been availed by the candidate.
- VI. Valid relevant category certificate issued by the Competent Authority, if any applicable.



The appointment of the above candidates shall further be subject to the following conditions:-

1. The salary of the appointee (s) shall not be drawn and disbursed to them unless satisfactory report in respect of genuineness of their qualification/diploma certificate/Date of birth/relevant category and other pre-requisite certificate(s) is received from the concerned issuing authority. In case during the course of verification of the requisite documents, turns out to be fake/fictitious, the appointment shall be cancelled ab-initio and appropriate criminal proceedings against such candidate(s) shall be initiated accordingly.
2. The inter-se-seniority of the appointee(s) shall be determined in accordance with the merit secured by the appointee(s) in the selection list prepared by the Services Selection Board.
3. The appointee(s) shall furnish an undertaking as per the enclosed format.
4. The appointment of the above candidates shall be subject to outcome of writ petition(s), if any, pending before a competent Court of Law.
5. If by any chance candidates who is not eligible for the post manages to secure selection by way of misrepresentation and false information and it comes to notice at a later stage, he will be liable for cancellation of selection and criminal prosecution as well in light of the judgment rendered by the Hon'ble Supreme Court.
6. The appointment of candidates shall be governed by the New Pension Scheme as per SRO-400 of 2009 dated 24.12.2009.


