Whereas, a tentative Seniority List of Assistant Engineers (Diploma Holders), Jal Shakti Department as on 01.01.2023, has been issued/notified, vide Circular No. 05-JK (JSD) of 2023 dated 12.05.2023, for inviting the necessary objections, if any, from the members of the service, in respect of assigned position in the seniority list to which they belong or their Date of Birth thereof, within a period of 15 days, from the date of issuance of the Circular; and

2. Whereas, in pursuance of the above, 04 representations have been received from various officers within the stipulated time. The issues raised therein have been examined with reference to rules governing the subject and, accordingly, these representations have been decided, as brought out in **Annexure-A**.

3. Whereas, on the recommendations of J&K Public Service Commission/Departmental Promotion Committee vide Government Order No.122-JK(JSD) of 2023 dated 30.05.2023 and vide Government Order No.160-JK(JSD) of 2023 dated 17.07.2023, regularization/promotion order in respect of (09) nine more Junior Engineers (Diploma Holders) as Assistant Engineers have been issued and they are required to be incorporated in the Final Seniority List at appropriate places; and

4. Whereas, the seniority of such officers whose regularization as Assistant Engineers (Diploma Holders) has been deferred/withheld by the DPC/PSC for want of vigilance clearance/pending departmental enquiry, etc. and their seniority shall be fixed at appropriate places as and when their regularization order as Assistant Engineers is issued.

5. Now, therefore, Final Seniority List of (retired/in-service) Assistant Engineers (Civil) (Diploma Holders), Jal Shakti Department as on 01.01.2023, forming **Annexure-B** to this order is hereby issued for information of the concerned members of the service, which shall be subject to condition that:-

- i) the inter-se-seniority position of the member of the Service shall be without prejudice to the outcome of writ petitioner(s), pending in any competent Court (s) of Law; and
  - ii) the Date of Birth reflected in the Final Seniority List shall in no manner be construed as final and shall be subject to the entries recorded in the individual service books/ date of birth certificate, issued by the Competent Authority. Further, the reserved category



status reflected against the officers in the final seniority list shall be subject to its authentication and verification from the Competent Authority.



1	Shri Parvez Ahmad Wani, retired I/c AEE	He has represented for his regularization as AE	<p>As per available records, Shri Parvez Ahmad Wani, has been figuring at Sr.No.841 (DoB:03.04.1960) in the final Seniority list of Junior Engineers (Diploma Holders) notified vide Govt. Order No.450-PW (Hyd) of 2019 dated 27.11.2019 as on 01.01.2019. Among others, the officer was placed as I/c AE vide Govt. Order No.333-PW (Hyd) of 2018 dated 24.09.2018.</p> <p>Perusal of Matriculation Date of Birth Certificate issued by the J&amp;K State Board of School Education, and 1<sup>st</sup> page of Service Book, produced by the officer reveals that the actual DoB of the officer is "15.09.1958" instead of "03.04.1960".</p> <p>The representee figures between Shri Shabir Hussain (DoB: 23.11.1961) and Shri Rattan Paul (RBA) (DoB; 11.02.1962), both of whom have been regularized as AE w.e.f. 01.06.2019 vide Govt. Order No.101-JK(JSD) of 2023 dated 12.05.2023, against the promotion quota vacancies. Since the representee retired on superannuation on 30.09.2018 i.e. before the date, the officers Senior/Junior to him have been regularized as AE, therefore, the representation does not have any merit. Hence, rejected.</p>
2	Shri Abdul Rashid Wani, retired I/c AE	He has represented for his regularization as AE	<p>As per available records, Shri Abdul Rashid Wani has been figuring at Sr.No.882 (DoB:01.03.1959) in the final Seniority list of Junior Engineers (Diploma Holders) notified vide Govt. Order No.450-PW (Hyd) of 2019 dated 27.11.2019 as on 01.01.2019. Among others, the officer was placed as I/c AE vide Govt. Order No.333-PW (Hyd) of 2018 dated 24.09.2018.</p> <p>The officers Senior/Junior to him namely, Shri Gh Rasool Malik (DoB: 01.02.1962) and Shri Mohd Ashraf (DoB: 04.03.1960) have been regularized as AE w.e.f. 01.11.2019 vide Govt. Order No.101-JK (JSD) of 2023 dated 12.05.2023, against the promotion quota vacancies. Since the officer in question retired on superannuation on 28.02.2019, i.e. before the date when the officers Senior/Junior to him have been regularized as AE, therefore, the</p>



			representation does not merit consideration. Hence, rejected.
3	Sh. Ashok Kumar Gupta, retired I/c Assistant Engineer	He has represented for his regularization as AE	Upon receipt of the Vigilance Clearance of the retired officer, regularization order in his favour stands issued vide Govt. Order No.122- JK (JSD) of 2023 dated 30.05.2023. Hence the representation stands disposed off.
4.	Representation of All J&K Diploma Engineers Association.	<p>In the year 2011, 272 posts of AEs were created vide G.O No.501-PW (Hyd) of 2011 dated 30.12.2011 by reduction of equal no. of posts of JE Grade-I (Diploma Quota).</p> <p>Their request is to reserve these posts of AEs for Diploma Holders only.</p>	<p>Vide Govt. Order No. 370- PW (Hyd) of 2011 dated 26.09.2011 read with Govt. Order No. 501- PW (Hyd) of 2011 dated 30.12.2011, 272 posts of Junior Engineers Grade-I have been converted/re-designated as Assistant Engineers.</p> <p>Thereafter, vide Govt. Order No. 507-PW (Hyd) of 2011 dated 30.12.2011, all eligible JE Grade-I were placed as AE. Further, vide Govt. Order No.162-PW (Hyd) of 2013 dated 21.06.2013, remaining vacant posts of AEs were utilized for placement of JE (Diploma Holders) as AEs, a special dispensation for the diploma holders.</p> <p>Also, vide Government Order No. 233-PW (Hyd) of 2013 dated 29.08.2013, the sanctioned strength of the post of Assistant Engineers has been notified as 551 including the 272 posts created vide aforesaid Govt. Orders. This G.O. forms the Schedule to the recruitment rules in force.</p> <p>The representation has been considered in context of the above position. These orders reveal that the conversion of JE Grade -I posts to AE was not by reduction of JE Grade-I (Diploma Quota) exclusively, falsifying the very basis of the claim made in the representation. Further, not only all those who were eligible were placed as AE but even a special concession was accorded in favour of the Diploma Holder JEs to place them as AEs. It is also to be noted that the sanctioned posts have been notified by the government as schedule to the rules.</p> <p>Once the directions contained in the relevant Govt. Order(s) are implemented, there remains no question of reserving any posts for any specific stream. It is trite that the origin of the post does not matter once it is notified as part of the overall scheme. Hence their representation, being factually incorrect, misleading, and merit less, is rejected.</p>


