

The appointee(s) shall be allowed to join after production of the following certificates/documents (in original) to be verified separately:-

- I. Academic/Technical qualification Certificates.
- II. Matriculation/Date of Birth certificate.
- III. Domicile certificate issued by the Competent Authority.
- IV. Health Certificate from the concerned District Chief Medical Officer.
- V. Certificate from the District Industries Centre (DIC) and District Employment and Counseling centre to the effect that no loan under any self employment scheme is outstanding against the candidate(s).
- VI. Relevant category certificate issued by the Competent Authority, if any applicable.

The appointment of the above candidates shall further be subject to the following conditions:-

- a. The clearance received from the Criminal Investigation Department, J&K is provisional and it shall be mandatory for the appointee to fill in the Verification Rolls (V-Rolls) as available through the online mode under the Electronic Employment Verification System (EVS).
