3. In case any candidate fails to join within the period of twenty one (21) days from the date of issuance of this order, his/her appointment as Junior Engineer (Civil) shall be deemed to have been cancelled ab-initio without any notice.

4. The appointees shall be allowed to join only after production of the following certificates/documents (in original), to be verified separately: -

- i. Educational/Technical Qualification (Degree/ Diploma Certificate) issued by the recognized Institute/University valid for employment.
- ii. Matriculation/DoB Certificate.
- iii. Domicile Certificate issued by the Competent Authority.
- iv. Health Certificate from the concerned District Chief Medical Officer.
- v. Relevant category certificate issued by the Competent Authority, if any applicable.

5. Besides, the appointment of the above candidates shall further be subject to the following conditions:-

- a) Each appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification from the concerned issuing authorities, any of the above certificates are found to be fake/forged, his/ her appointment as Junior Engineer (Civil) in the Jal Shakti Department shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against him/her.
- b) Each appointee shall furnish a Certificate from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under any self-employment scheme has been availed by the candidate. In the alternative, if the candidate(s) has taken such a loan, to be ascertained by the DDO concerned from the District Industries Centre (DIC) and District Employment and Counseling Centre, he/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO Concerned from his/her salary. DDO Concerned shall obtain an affidavit from the concerned appointee(s) regarding both relinquishment of proprietorship and stakes, if any in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.

6. It is further directed that:

- a) The salary of the appointees shall not be drawn and disbursed to him/her unless satisfactory report in respect of genuineness of his/her qualification/Degree/Diploma Certificate/Relevant Category Certificate/Date of birth and other pre-requisite certificate(s) is received from the concerned issuing authority.
- b) The inter-se-seniority of the appointees shall be determined in accordance with the merit secured by him/her in the selection list prepared by the J&K Service Selection Board in terms of J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- c) The appointment of the candidates shall be governed by the "New Pension Scheme" in terms of SRO-400 of 2009 dated 24.12.2009.
- d) The appointee(s) shall be on probation for a period of two (02) years.
- e) The appointments of the above candidates shall be subject to outcome of writ petition(s), if any, pending before any competent Court of Law.
