  - To ensure whether the necessary procedures have been followed for execution and incurring expenditure on the components of the DPR (as approved by the Competent Authority);
  - To ascertain whether the physical progress is commensurate with the financial progress as mentioned in the UCs;
  - To examine whether all the documents have been placed on record and are found to be in order;
  - Any other aspect relevant to the issuance of UC.

3. The committee shall furnish its recommendations/ observations within 7 days of reference being made to it.


