
Whereas, on the recommendations of Departmental Promotional Committee/J&K Public Service Commission, among others, Shri Vinod Kumar Bagati Assistant Engineer was regularized/promoted as Assistant Executive Engineer, w.e.f. 14.09.2001 vide Government Order No.269-PW (Hyd) of 2013 dated 04.10.2013 (figuring at Sr. No. 190) in the said Govt. Order; and

Whereas, vide Govt. Order No.329-PW (Hyd) of 2013 dated 26.11.2013, final seniority list of Assistant Executive Engineers as it stood on 01.01.2007, were notified. In the said final seniority list Shri Vinod Kumar Bagati figuring at serial No. 208 i.e below Shri Ravi Kumar (Sr. No. 207) and above Shri Naresh Kumar ((Sr. No. 209);and

Whereas, again tentative Seniority list of AEEs, was notified/issued vide Circular No. 03-PHE/I&FC of 2019 dated 16.04.2019 for inviting necessary objections and the name of Shri Vinod Kumar Bagati had inadvertently been missing in the said tentative seniority list. Shri Bagati was not submitted any objection at that point of time in this regards and thereafter, vide Govt. Order No. 289-PW( Hyd) of 2019 dated 24.07.2019, final seniority list of AEEs as it stood on 01.01.2019 was issued/ notified; and

Whereas, Shri Vinod Kumar Bagati, retired I/C Executive Engineer has submitted a representation requesting therein to incorporate his name in seniority list and confirmed him as Executive Engineer; and

Whereas, the case has been examined and it has been observed that the inter-se-seniority of Shri Vinod Kumar Bagati, AEE is require to be fixed at appropriate place in the final seniority list of AEEs as it stood on 01.01.2019, notified vide Govt. Order No. 289-PW( Hyd) of 2019 dated 24.07.2019 at Sr. No. 156-A i.e below Shri Bashir Ahmad Baba (Sr.No. 156) and above Shri Vijay Kumar (Sr. No 157); and



Whereas, accordingly, vide this department's endorsement No. No.JSD/HRM/60/2021 dated 29.12.2021 a notice with regard to fixation of inter-se-seniority of Shri Vinod Kumar Bagati, Assistant Executive Engineer in the final seniority list of Assistant Executive Engineers notified, vide Govt. Order No.289-PW(Hyd) of 2019 dated 24.07.2019 at Sr.No.156-A i.e below Shri Bashir Ahmad Baba (Sr.No.156) and above Shri Vijay Kumar (Sr.No.157) has been issued/ published through print media, all the concerned likely to be affected are called upon to file their objections, if any, within a period of 15 days from the date of issuance of the said notice, failing it shall be presumed that nobody has any objection in this regard and necessary orders to this effect shall be issued, The said notice has also been hosted in the official website of the department. As per records, the department has not received any objection in this behalf.

Now, therefore, the inter-se-seniority of Shri Vinod Kumar Bagati, Assistant Executive Engineer shall and shall be deemed to be have been fixed in the final seniority list of Assistant Executive Engineers notified, vide Govt. Order No.289-PW(Hyd) of 2019 dated 24.07.2019 at Sr.No.156-A i.e below Shri Bashir Ahmad Baba (Sr.No.156) and above Shri Vijay Kumar (Sr.No.157) at appropriate place, i.e. the position he has assigned in the final seniority list of Assistant Engineers (Degree Holders), prior to his regularization/ promotion as AEE.


