On the recommendations of J&K Services Selection Board received through General Administration Department, sanction is hereby accorded to the appointment of following candidate as Helper in the Ravi Tawi Irrigation Complex Jammu on regular/ temporary basis, in the pay level SL-1 (Rs. 14800-47100), with immediate effect:-

The appointee shall report to the Chief Engineer, Ravi Tawi Irrigation Complex Jammu within a period of 21 days from the issuance of this order and in case he fails to join within the stipulated time, he shall forego his right to appointment, which shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join only on production of the following certificates (in original) to be verified subsequently:-

1. Academic/Technical Qualification Certificates.
2. Matriculation/ Date of Birth Certificate.
3. Health certificate from the concerned Chief Medical Officer of the District.
4. Domicile Certificate.
5. Certificate from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self employment scheme has been availed by the appointee.
6. Relevant Category Certificate.
7. Any other relevant documents if required.

The appointment of the above candidate, as Helper shall further subject to the following conditions:-

- a) The appointee shall give an undertaking dully attested by the Judicial Magistrate to the effect that in case adverse report about his character and antecedents is received from Additional Director General of Police (CID),

- J&K, he shall have no right to claim his appointment as mentioned above and his appointment, as such, shall be deemed who have been cancelled ab-initio.
- b) The appointment shall be made in terms of the Jammu and Kashmir Probationer (condition of Service, pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O. 192 of 2020 dated 17.06.2020.
 - c) If by any chance candidate manages to secure selection by way of misrepresentation and false information and it comes to notice at a later stage, he will be liable for cancellation of selection and criminal prosecution as well in light of the judgment rendered by the Hon'ble Supreme Court.
 - d) Verification/Genuineness of the qualification, reserved category certificates from the concerned issuing authority.
 - e) The appointee shall furnish an undertaking as per the enclosed format.

The appointment shall be issued subject to outcome of any writ petition(s)/OA, if any pending on the subject; and

The salary of the appointee shall not be drawn to him unless the satisfactory report in respect of above are received in his favour; and

The appointment of the above candidate shall be Governed by the (New Pension Scheme) as per SRO-400 of 2009 dated 24.12.2009; and

The inter seniority of the appointee shall be drawn in accordance with the merit secured by the appointee in the selection list prepared by the J&K Services Selection Board.


