- ii. Matriculation/Date of Birth certificate.
- iii. Domicile certificate issued by the Competent Authority.
- iv. Health Certificate from the concerned District Chief Medical Officer.
- v. Certificate from the District Industries Centre (DIC) and District Employment and Counseling centre to the effect that no loan under any self employment scheme has been availed by the candidate.
- vi. Valid relevant category certificate issued by the Competent Authority.

The appointment of the above candidates shall further be subject to the following conditions:-

- 1 Each appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his/her Qualification/ Date of Birth/ Reserved Category Certificates from the concerned issuing authorities is found fake/forged, his/her appointment as Draftsman (Civil) in the Jal Shakti Department shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her.
- That if the candidate(s) has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and unit/enterprise and also stakes, if any, in such self employment unit/enterprise before the joining EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain stacks, if any in such a self employment unit/enterprise and recovery to be made and also personally monitory its recovery.
- The salary of the appointees shall not be drawn and disbursed to him/her unless satisfactory report in respect of genuineness of his/her qualification/Relevant Category Certificate/ Date of birth and other pre-requisite certificate(s) is received from the concerned issuing authority.
- The inter-se-seniority of the appointees shall be determined in accordance with the merit secured by him/her in the selection list prepared by the J&K Services Selection Board and in terms of J&K Civil Services (Classification, Control and Appeal) Rules, 1956
- The appointment of the candidates shall be governed by the "New Pension Scheme' as per SRO-400 of 2009 dated 24.12.2009.
