
Consequent upon his appointment, the candidate shall report in the office of the Chief Engineer, Irrigation and Flood Control, Kashmir, within a period of twenty one (21) days from the date of issuance of this order. In case the candidate fails to join within the stipulated period, his appointment shall be deemed to have been cancelled ab-initio without any further notice:

The appointee shall be allowed to join only after production of the following certificates/documents (in original) to be verified separately:-

- I. Educational/Technical qualification (Degree/Diploma Certificates) issued by the recognized Institute / University.
- II. Matriculation/Date of Birth certificate.
- III. Domicile certificate issued by the Competent Authority.
- IV. Health Certificate from the concerned District Chief Medical Officer.
- V. Certificate from the District Industries Centre (DIC) and District Employment and Counseling center to the effect that no loan under any Self Employment Scheme is outstanding against the candidate.

The appointment of the above candidate shall further be subject to the following conditions:-

1. The appointee shall furnish an undertaking in the shape of an affidavit to the effect that he has no criminal record and is not facing any criminal proceedings in any Hon'ble Court of Law.
2. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of genuineness of his qualification/diploma certificate/Date of birth/relevant category and other pre-requisite certificate is received from the concerned issuing authority. In case during the course of verification of the requisite



documents, turns out to be fake/fictitious, the appointment shall be cancelled ab-initio and appropriate criminal proceedings against the candidate shall be initiated accordingly.

3. The inter-se-seniority of the appointee shall be determined in accordance with the merit secured by him in the selection list prepared by the J&K Services Selection Board.
4. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
5. The appointee shall be on probation for a period of two (02) years as per Rule 20 of J&K Civil Services (CCA) Rules, 1956.
6. The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, pending before any Competent Court of Law.
