Whereas, vide this department's letter dated 18.01.2022 Memorandum, Articles of Charges and Statement of Imputation were served to the accused Officers namely Shri Harbinder Singh Behl, the then I/C Executive Engineer, PHE City Division-1 Jammu presently attached in the office of Chief Engineer I&FC, Jammu and Shri Deepak Sharma, then AAO, PHE City Division-1 Jammu; and

Whereas, the department received the replies of the both accused Officers, in defense on the charge sheet served upon them; and

Whereas, the case has been examined and the competent authority has decided to appoint an Inquiry Officer to enquire into the charges framed viz-a-viz reply furnished by the accused officers; and

Now, therefore in terms of sub-rule (4) of Rule 33 of the J&K Civil Services (Classification Control and Appeal) Rules 1956, Shri Hamesh Manchanda, I/C Chief Engineer, I&FC, Jammu is hereby appointed as Inquiry Officer to enquire into the charges leveled against Shri Harbinder Singh Behl, then I/C Executive Engineer, PHE City Division-1 Jammu presently attached in the office of Chief Engineer I&FC, Jammu and Shri Deepak Sharma, the then AAO, PHE City Division-1 Jammu. Besides, Shri Madan Lal, I/C Assistant Executive Engineer, PHE City Division No. 1, Jammu shall be as Presenting Officer in the matter.
