- iii. Domicile Certificate issued by the Competent Authority.

- Health Certificate from the concerned District Chief Medical iv. Officer.
  - Certificate from the District Industries Centre (DIC) and District V. Employment and Counseling Centre to the effect that no loan under any self employment scheme has been availed by the candidate.
- Valid relevant category certificate issued by the Competent vi. Authority.

Besides, the appointment of the above candidates shall further be subject to the following conditions;

- a) The appointee shall furnish an undertaking in the shape of affidavit as per the annexure "A" to this Government Order.
- b) The salary of the appointee shall not be drawn and disburse to them unless and until satisfactory report in respect of the genuineness of their qualification/degree certificate/DoB/ category certificate is received from the concerned issuing authorities.
