- iv. Service is verified with respect to Service Book with effect from 01.09.2021 to 01.10.2021.
- v. A certificate to the effect that the D.O.B recorded on the 1st page of Service Book is correct genuine & acceptable to the Department.
- vi. A copy of permission granted by the Administrative Department may be made in the Service Book under proper attestation to effect that the incumbent has been permitted to appear in Public Service Commission examination through proper channel.
