Consequent upon their appointment, the appointee(s) shall report in the office of respective Chief Engineer within a period of twenty one (21) days from the date of issuance of this order for fulfillment of other requisite formalities. In case the candidate(s) fails to join within the aforementioned stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.

The appointee(s) shall be allowed to join only after production of the following certificates/documents (in original) to be verified subsequently:-

- I. Academic/Qualification Certificates.
- II. Matriculation/Date of Birth certificate.
- III. Domicile certificate issued by the Competent Authority.
- IV. Health Certificate from the concerned District Chief Medical Officer.

The appointment of the appointee(s) shall further be subject to the following conditions:-

- a) That the appointee(s) shall give an undertaking in the shape of an affidavit to the effect that if on verification, his/her Qualification/Date of Birth/Category Certificate(s), if any, from the concerned issuing authority are found to be fake/forged, the claim of the appointee(s) for appointment as Class IV(MTS) shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against him/her.
- b) That the appointee(s) shall give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate First Class, to the effect that the applicant is not a government employee as on date and none of the family members other than the applicant has taken benefit of Jammu and Kashmir Rehabilitation Assistance Scheme. In case it turns out that the applicant(s) is/are already appointed or the benefit of compassionate appointment under Rehabilitation Assistance Scheme has been already extended to the family of the deceased, then the instant appointment shall be deemed to have been withdrawn ab-initio without any further notice.
- c) That the appointee(s) shall give an undertaking in the shape of an affidavit to the effect that he/she shall maintain properly the other family members who were dependent on the deceased and, in case, it is proved at any time that the dependent family members are being neglected or not being properly maintained by him/her, appointment shall be terminated forthwith.
- d) Any claim for transfer of appointment to any other family member shall invariably be rejected.
- e) If the candidate(s) has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the Domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stacks, if any, in such self employment unit/enterprise before the joining of the Government Service. He/she shall be the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit stacks, if any in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery.
