**Government Order No. 66 -JK (JSD) of 2025
Dated: 13. 03.2025**

Whereas, Er. Aafir Ahmad Bhat was appointed as Junior Engineer (Civil) in Jal Shakti Department vide Government Order No. 39-JK(JSD) of 2024 dated 20.02.2024 and his services were placed at the disposal of the Chief Engineer, PHE Kashmir; and

Whereas, Er. Aafir Ahmad Bhat intimated that he has been appointed as Junior Engineer in the Public Works (R&B) Department, vide Government Order No. 285-PW(R&B) of 2024 dated 30.09.2024 and tendered his resignation from the post of Junior Engineer (Civil) in Jal Shakti Department with effect from 03.10.2024; and

Whereas, the Chief Engineer, PHE Kashmir vide his communication as mentioned in the reference above, has forwarded the case of Er. Aafir Ahmad Bhat, Junior Engineer to the Jal Shakti Department for acceptance of his resignation; and

Whereas, the matter has been examined/considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service; and

Whereas, Rule 21(1) of J&K Services (Classification, Control & Appeal), Rules 1956, provides as under:-

At any time before the expiry of the prescribed period of probation, the appointing authority may:-

[Handwritten signatures and initials]

- a) *Suspend the probation of a probationer and discharge him from the service for want of vacancy; and*
- b) *At his discretion terminate the probation of a probationer and discharge him from service.*

Now, therefore, in terms of Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered Er. Aafir Ahmad Bhat, Junior Engineer (Civil) is hereby accepted from the date he tendered his resignation i.e 03.10.2024 on his own request and he is discharged from the post of Junior Engineer (Civil) in the Jal Shakti Department.


