Subject:- Authentication of Date of Birth of Shri Ghulam Mustafa Mir, retired Executive Engineer.

Whereas, Secretary, JKWRRA, vide letter dated 18.04.2024, intimated that the pension case of Shri Ghulam Mustafa Mir, retired Executive Engineer, was submitted to the Accountant General (AG) Office; and

Whereas, the Accountant General (AG) Office, vide communication dated 30.05.2024, pointed out tampering/ alteration in the date of birth recorded in the Service Book of Shri Ghulam Mustafa Mir and requested that the correct date of birth be established through the concerned Administrative Department in terms of Article 35-AA (c) of the J&K CSR Vol-I; and

Whereas, Secretary, JKWRRA, vide letter dated 03.07.2024, requested the Administrative Department to establish the correct date of birth of the retired officer; and

Whereas, the case was examined in the department, and vide letters dated 22.08.2024, 29.11.2024 and 10.01.2025, J&K Board of School Education was requested to verify the date of birth of Shri Ghulam Mustafa Mir based on the matriculation certificate bearing Roll No. 14993 (Session June 1979); and

Whereas, Joint Secretary, J&K Board of School Education, vide letter dated 24.01.2025 confirmed the date of birth of Shri Ghulam Mustafa Mir as 07.05.1962 based on the verified matriculation records; and

Whereas, the case was again examined in the department in consultation with Director Finance who confirmed that the date of birth recorded in the service book of Shri Ghulam Mustafa Mir is not in order and needs to be settled as provided in terms of provisions contained in Article 35-AA (c) of J&K CSR Vol-I and in consonance with the matriculation certificate duly verified by the Jammu & Kashmir Board of School Education.

Now therefore, in terms of Rule 287 of GFR 2017 and as per Article 35-AA (c) of J&K CSR Vol-I, the date of birth of Shri Ghulam Mustafa Mir, retired Executive Engineer is deemed to have been authenticated as 07.05.1962 (Seventh May Nineteen Hundred Sixty Two).


