Whereas, Shri Ali Mohd Dar, retired Assistant Executive Engineer, submitted a representation for inclusion of his name in the final seniority list of Junior Engineers (Degree Holders); and

Whereas, Shri Ali Mohd Dar was initially appointed as a Sectional Officer in the year 1982 and has acquired his AMIE (Section A&B) from the Institutes of Engineers (India), Kolkata in 1998; and

Whereas, the name of the applicant was figured in the tentative seniority list of Junior Engineers (Degree Holders) issued in the year 2005, but his name remained missing from all the final seniority lists issued from time to time; and

Whereas, on the basis of the tentative seniority list of Junior Engineers (Degree Holders) issued in 2005, among others, Shri Ali Mohd Dar was placed as I/c Assistant Engineer in 2006 and I/c Assistant Executive Engineer in 2009. The official retired on 28.02 2022; and

Whereas, vide this department letter dated 11.08.2023 and 22.09.2023, Chief Engineer, PHE Kashmir was requested to furnish a detailed report in the matter. In response, the concerned Chief Engineer vide letter dated 14.09.2023 has forwarded the service documents for inclusion of his name in the final seniority list of Junior Engineers (Degree Holders); and

Whereas, vide this department letter dated 25.10.2023, the Chief Engineer was again requested to provide specific recommendations regarding the non-inclusion of Shri Ali Mohd Dar's name in the seniority lists. The Chief Engineer vide letter 09.01.2024 has intimated that the report was sought from concerned Superintending Engineer, Hydraulic Circle, Srinagar who has reported that the reasons with regard to non-inclusion of Shri Ali Mohammad Dar, retired I/c AEE in the seniority list of Junior Engineer issued from time to time till the retirement of the said officer is not known to the Division, as the seniority list is maintained by the Administrative Department; and

Whereas, the details of placements/regular promotion of Shri Ali Mohd. Dar as well as his counterparts in the tentative seniority list of Junior Engineers notified vide Circular No. 01 of 2005 dated 14.02.2005 are given as under:-
