- II. Matriculation/Date of Birth certificate.
- III. Domicile certificate issued by the Competent Authority.
- IV. Health Certificate from the concerned District Chief Medical Officer.
- V. Certificate from the District Industries Centre (DIC) and District Employment and Counseling centre to the effect that no loan under any self employment scheme has been availed by the candidate.
- VI. Valid relevant category certificate issued by the Competent Authority, if any applicable.

The appointment of the above candidate shall further be subject to the following conditions:-

1. The appointee shall furnish an undertaking in the shape of an affidavit to the effect that the appointee have no criminal record and is not facing any criminal proceedings in any Hon'ble Court of Law.

2. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of genuineness of his qualification/diploma certificate/Date of birth/relevant category and other pre-requisite certificate(s) is received from the
