

Subject: -Final/updated seniority list of Executive Engineers (Civil) of PHE, I& FC Department.

Whereas, a tentative seniority list (year wise) of Executive Engineers (Civil) of PHE, I& FC Department was published/ issued vide Circular No. 05- PHE, I& FC (Hyd) of 2018 dated 26.10.2018 for inviting the necessary objections, if any, from the members of the service, within a period of 15 days from the date of issuance of the instructions; and

Whereas, seventeen (17) Executive Engineers who were not been included in the aforesaid tentative seniority list because of non-availability of records viz. date of birth as they had retired from service; and

Whereas, after receipt of the records viz. date of birth of about 17 retired officers (Executive Engineers) were examined in the department and it has been found that 03 officers stood retired before 31.12.2007 and their names not incorporated in the updated seniority list as on date. However, the names of remaining retired officers have been incorporated in the seniority list at their appropriate places; and

Whereas, vide Government Order No. 87- PW (Hyd) of 2018 dated 27.02.2018, the following two officers (AEEs) were also confirmed/regularized as Executive Engineers (Civil) on the recommendations of DPC/ PSC:-

Whereas, the names of the above mentioned two officers have also been included in the seniority list at their appropriate places on the basis of their date of regularization; and

Whereas, the J&K Public Service Commission has conveyed regularization/confirmation of eighteen (18) more Assistant Executive Engineers as Executive Engineers belonging to reserved categories; and

Whereas, the formal orders could not been issued in their favour in view of the fact that the matter of reservation under promotion quota is presently sub-judice in the Apex Court of Supreme Court of India; and

Whereas, the matter of issuance of seniority in respect of these 18 reserved category candidates will be issued separately and their names shown at their appropriates places after the final verdict of the Apex court of India; and

Whereas, one more officer namely Shri Shesh Kumar Sharma, represented this department and made a submission that the date of regularization of Shri Padam Nath Bali has been wrongly shown as 01.08.2009 whereas, his actual date of regularization is 30.04.2010 as per corrigendum dated 16.01.2015; and

Whereas, his case has been also examined in the department keeping in consideration the corrigendum issued vide endorsement No. PHE,IFC/HRM/DPC/03/2014 dated 16.01.2015 and necessary corrections made to the extend of date of regularization as 30.04.2010 instead of 01.08.2009 and position assigned to him in the final seniority list of AEEs i.e below Shri Sohan Krishan Khurdi and above Shri Ali Mohammad Mir; and

Now, therefore, final/ updated seniority list of confirmed Executive Engineers (Civil) of PHE, I& FC Department as on date is hereby notified/issued forming **Annexure** to this Government Order for circulation among all the members of the service. The updated seniority list is also available on the website of the Department i.e. **www.jkpheirrigation.nic.in.**

The seniority shall be without prejudice to the final outcome of writ petition(s), if any pending before any competent court of law.

The date (s) of birth recorded in the final/ updated seniority list shall not be taken as authentic and shall be subject to further verification from the Service book/ Matriculation certificate of the concerned officer (s).
