**Whereas**, vide Government Order No. 329-PW (Hyd) of 2013 dated 26.11.2013, final seniority list of Assistant Executive Engineers (Civil) of PHE, I& FC Department as it stood on 01.01.2007, was issued; and

**Whereas**, some more Assistant Engineers were also regularized as Assistant Executive Engineers on the recommendations of the Departmental Promotion Committee/ Public Service Commission, by virtue of different Government orders from time to time, from various retrospectively dates; and

**Whereas**, a year wise tentative seniority lists of Assistant Executive Engineers as on 01.01.2008 to 01.01.2017 was published/ notified vide Circular No. 04-PHE, I&FC (Hyd) of 2017 dated 31.03.2017 for inviting necessary objections.

**Whereas**, various objections so received were examined in the department and the matter was taken up with the General Administration Department vide U.O. No. PHE,I&FC/HRM/SL/26/2017 dated 24.08.2017 for seeking their advice/guidance regarding some seniority dispute between reserve category and general category candidates; and.

**Whereas**, such Assistant Engineers whose cases of regularization/ promotion as Assistant Executive Engineers have been deferred by the DPC/ PSC for want of vigilance clearance, pending departmental inquiry or any others reason, their seniority shall be fixed at suitable positions later after they cleared for regularized/promotion as Assistant Executive Engineers by the DPC/ PSC; and

**Whereas**, vide Circular No. 03- PHE/ I& FC of 2019 dated 16.04.2019, revised tentative Seniority List of Assistant Executive Engineers (Civil) as on 01.01.2019 was issued for inviting the objections, if any , from the concerned members of the service, within a period of 15 days from the date of issuance of the said Circular; and

**Whereas**, the department has received (five number) objections/ representations with regard to fixation/ re-fixation of seniority and the same were disposed off suitably. A brief list of objections received and disposed thereof is given at Annexure- I to this order.

Now, therefore, Final seniority list of confirmed retired/ in-service Assistant Executive Engineer, Public Health Engineering/ Irrigation and Flood

Control Department as on 01.01.2019 is hereby issued forming Annexure-II to this Government order for information among all the members of the service. The final seniority list is also available on the official website of the department i.e. [www.jkpheirrigation.nic.in](http://www.jkpheirrigation.nic.in), subject to the following conditions:-

1. The Date of Birth reflected in the final seniority list shall be subject to its authentication/verification from the Service Book/Date of Birth Certificate of the concerned officers, as envisaged under rules.
2. The reserved Category status reflected against the officers in the final seniority list shall also be subject to its authentication/verification from the competent issuing authority.
3. The Seniority shall be without prejudice to the final outcome of writ petition(s), if any pending before any competent court of law.






