The appointment of the above candidates, as Class-IV shall further subject to the following conditions:-

a. The appointee shall give an undertaking dully attested by the Judicial Magistrate to the effect that in case adverse report about his/her character and antecedents is received from Additional Director General of Police (CID), J&K, he/she shall have no right to claim his/her appointment as mentioned above and his/her appointment, as such, shall be deemed to have been cancelled ab-initio.

- b. All these appointment shall be made in terms of the Jammu and Kashmir Probationer (condition of Service, pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O. 192 of 2020 dated 17.06.2020.
- c. If by any chance candidates who is not eligible for the post manages to secure selection by way of misrepresentation and false information and it comes to notice at a later stage, he/ she will be liable for cancellation of selection and criminal prosecution as well in light of the judgment rendered by the Hon'ble Supreme Court.
- d. Verification/Genuineness of the qualification, reserved category certificates from the concerned issuing authority.
- e. The appointee shall furnish an undertaking as per the enclose format

The salary of the appointees shall not be drawn to them unless the satisfactory report in respect of above are received in their favour; and

The inter-se seniority of the appointee shall be drawn in accordance with the merit secured by the appointee in the selection list prepared by the J&K Services Selection Board.
