Whereas, on the recommendation of Jammu and Kashmir Service Selection Board vide their letter No. SSB/Sel/Secy/013/1867-70, dated 08.04.2013, among others, Sh. Mohammad Shahid, S/o Ghulam Mohammad, R/o Natipora, Srinagar has been appointed as Junior Engineer (under HC vision Disability), vide Govt. Order No. 138-PW (Hyd) of 2013, dated 25.04.2013; and


Whereas, Sh. Mohammad Shahid, Junior Engineer (Diploma Holder) represented to this Department on 10.07.2017, wherein among other things, requested for fixation of his seniority in the seniority list of Junior Engineers (Degree Holders) on the grounds that he has been selected as Junior Engineer on Degree basis; and

Whereas, the case was examined in the department accordingly vide this department letter No. PHE/ I&FC/HRM/174/2017 dated.10.10.2017, Service Selection Board was requested to intimate as to whether Sh. Mohammad Shahid, S/o Ghulam Mohammad, R/o Natipora, Junior Engineer has been selected on the basis of an Engineering ( Degree or Diploma); and

Whereas, Service Selection Board vide No. SSB/Sel/Secy/17/442-44, dated 09.01.2018, mentioned that the candidate namely Shri Mohammad Shahid, S/o Ghulam Mohammad, R/o Natipora, figuring at S. No. 02 under HC Category, has obtained the weightage of both Diploma as well as Degree; and

Whereas, Shri Mohammad Shahid filed a writ petition SWP No. 2023/2017 and contempt petition CPSW No. 68/2018 titled Mohammad Shahid Vs Mr. Raju & Ors before the Hon'ble High Court for fixation of his seniority in the seniority list of Junior Engineer ( Degree Holders); and

Whereas, the case was again examined in the department and it has been decided to fix the inter-se-seniority of Shri Mohammad Shahid, in the cadre of Junior Engineers (Degree Holders) at appropriate place from the date of his appointment w.e.f. 25.04.2013.



Now, therefore, before fixation of seniority of Shri Mohammad Shahid, Junior Engineer, in the seniority list of Junior Engineers (Degree Holders), notified, vide Government Order No. 121- JK ( JSD) of 2020 dated 30.04.2020 at Serial 526-A i.e below Shri Sheikh Imtiyaz Ali ( Serial No.526 ) and above Ms. Anjali Bhagat (Serial No. 527) , all the concerned likely to be affected are called upon to file their objections, if any, within a period of 21 days from the date of publication of this notice in the print media, failing which, it shall be presumed that nobody has any objection and orders to this effect shall be issued accordingly.


